

# FIRST CALL FOR PAPERS FINANCIAL REPORTING – IX WORKSHOP

The School of Economics, Management and Statistics of the University of Bologna and Financial Reporting are jointly organising the **IX Financial Reporting Workshop**.

The event will take place in Bologna on the 14<sup>th</sup> and 15<sup>th</sup> June 2018.

The aim of the Workshop is to discuss high quality papers on all aspects of financial reporting and business communication. We encourage the submission of both empirical and theoretical papers and case studies addressing financial reporting issues.

Topics may include:

- The introduction and the effectiveness of IAS/IFRS
- The role of financial reporting in capital markets
- The relationship between financial reporting and corporate governance
- Current and future reporting frameworks for risk/environmental disclosure
- Social and environmental disclosure
- Accounting choices and earnings quality
- The role of annual reports and other types of business communication for financial reporting purposes
- The role of narrative disclosure in financial reporting
- Fraud in financial reporting
- International accounting harmonization
- Audit quality and financial statements

All papers will be peer-reviewed prior to acceptance for the workshop; each paper accepted for presentation will be assigned to a parallel session.
